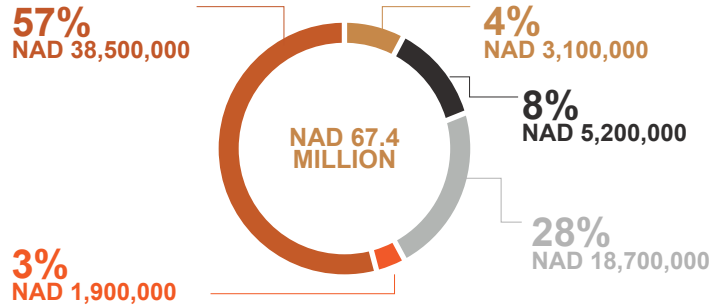

PROGRAM COMPOSITION AS AT 30 APRIL 2026

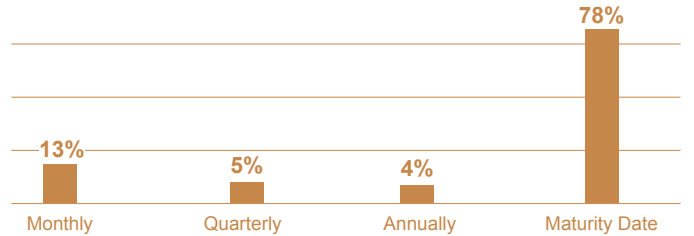
Investment amount
